RESOLUTION DECLARING THE MUNICIPALITY OF TIGBAUAN ANDER A STATE OF CALAMITY

WHEREAS, the Municipality of Tigbauan was ranked number1 in the Province of Iloilo being infected by a viral diseases called Dengue Fever

WHEREAS, the viral disease is now an epidemic in the Municipality of Tigbauan, wherein as of July 26, 1998, 104 cases of children have been reported hospitalized

WHEREAS, rules and Regulations Implementing republic Act No. 8185 "An Act Amending Sec. 324 (d) RA 7160, Otherwise known as the Local Government Code of 1991, Sec 3, "defines CALAMITY as a state of extreme distress of misfortune produced by some adverse circumstances or events of great misfortunes or cause or loss or misery caused by natural forces such as earthquake typhoons, floods hurricanes, epidemic or other disaster causing widespread loss of and/or extensive damage to human lives, livestock, crops and property;

WHEREAS, in order that this can be given immediately and primary attention it is necessary to declare the Municipality of Tigbauan under a state of calamity to legalize the release of the calamity fund of the Municipality and Barangays affected by this diseases;

NOW, THEREFORE, on motion of Honorable Cecelia Garrido, Chairman, Committee on Health and Sanitation, and duly seconded by hon. Cornelia Teruel, Hon. Ramonita Alcala. and Hon. Ma. Bernadita T. Taasan;

RESOLVED, to declare the Municipality of Tigbauan under a State of Calamity;

RESOLVED FURTHER, to forward copies of this Resolution to Hon. Arthur Defensor, Governor, Province of Iloilo, to Dr. Rodolfo Dumayas, Provincial Health Officer and Dr. alfredo V. eudenia, Municipal Health officer, for their information and guidance.
