RESOLUTION REQUESTING HIS EXCELLENCY PRESIDENT JOSEPH EJERCITO-ESTRADA TO RECONSIDER HIS POSITION TO SUSPEND THE RELEASE OF INTERNAL REVENUE ALLOTMENT OF LOCAL GOVERNMENT UNITS.

WHEREAS, President Joseph Ejercito-Estrada was reported to have a position last week to suspend the release of the Internal Revenue allotment (IRA) of local government units;

WHEREAS, this measure will further aggravate the already cash strapped situation of the local government units throughout the country as a result of the issuance of Administrative Order No. 372 by former president Fidel V. Ramos withholding 10% of the IRA's of LGU's;

WHEREAS, IRA should have been spared from the mandatory budget services outbacks or suspensions of releases because the same will necessary result in the suspension or interruption of the operation and projects of LGU's;

WHEREAS, such suspension will also prevent local government officials from exercising their mandated duties to render basic services to their constituents, especially the poor;

NOW, THEREFORE, on motion of Hon. Honorable Ma. Bernadita T. Taasan, Chairman, Committee on Budget and Finance, Appropriation & Accounts and duly seconded by Honorable Remedios T. Torrato,

RESOLVED, AS IT IS HEREBY RESOLVE, to request His Excellency President Joseph Ejercito-Estrada To Reconsider His Position To suspend The Release of Internal Revenue Allotments Of Local Government Units,

RESOLVED FURTHER, to furnish a copy of this Resolution to the President of the Republic of the Philippines and the office of the Secretary of the Department of the Budget and management for their information and guidance.
