RESOLUTION REQUESTING THE ILECO I MANAGEMENT TO PROVIDE FOR ELECTIC METERS TO EACH BARANGAY WITHIN THE POBLACION AND TO CHEARGE ALL ELECTRIC CONSUMPTIONS OF STREET LIGHTS TO THE RESPECTIVE BARANGAY COUNCILS

WHEREAS, the Municipal Government of Tigbauan, thru Resolution No. 98-43 dated august 10, 1998 had transferred the operation and maintenance of all street lights to the respective barangays within the poblacion;

WHEREAS, it is necessary that each barangay unit concerned shall have their own electric meters so that they can provide funds for the payment of electric bills that will be charged to their respective barangay councils;

NOW, THEREFORE, on motion of Hon. Hon. Ma. Bernadita Taasan, Chairman, S.B. Committee on Budget and Finance, appropriation & Accounts and duly seconded by Hon. Cornelia T. Teruel ,

RESOLVED, to request the ILECO I management provide for electric meters to each brangay within the poblacion and to charge all electric consumptions of streets lights to the respective barangay councils,

RESOLVED FURTHER, to forward copies of this Resolution to all barangays concerned and ILECO I for their appropriate action.
