WHEREAS, Section 80 (b) of the Local government Code of 1991 (R.A 7160) states that the municipality shall establish the personnel selection Board to assist the local chief executive in the judicious and objective selection of personnel for employment as well as for promotion, and in the formulation of such policies as would contribute to employee welfare;

WHEREAS, Section 80 (c) provides that the members of the Personnel Selection Board shall be determined by resolution of Sanggunian;

WHEREAS, the Sangguniang Bayan of Tigbauan, Iloilo session assembled determined the Personnel Selection Board as follows:

2. Members:

  - b.) Representative of the Civil Service Commission if any
  - c.) Human Resource Management Officer III – LGU (Ex Officio member)
  - d.) All municipal department Heads - to represent on behalf of their respective offices
  - e.) Representative of 1<sup>st</sup> level position (Sal. Grade 1-9) and 2<sup>nd</sup> Level position (Salary Grade 10 & up)
