RESOLUTION AUTHORIZING THE MUNICIPAL TREASURER, MRS. EDNA T. TUERES TO RELEASE TH AMOUNT OF FIVE THOUSAND PESOS (5,000.00) AS FINANCIAL ASSISTANCE TO BRGY. NAMOCON, TIGBAUAN, ILOILO FOR THE FIFTY SIX (56TH) ANNIVERSARY CELEBRATION OF THE FIRST (1ST) AMBUSH IN PANAY AND ROMBLON, CHARGEABLE AGAINTS THE HUMAN RESOURCE DEVELOPMENT FUND OF THE 20% MUNICIPAL IRA FUND

WHEREAS, September 2 of every year is dedicated to commemorate the celebration of the First (1st) ambush site at Brgy. Namocon, Tigbauan, Iloilo, wherein our fellow Tigbauenos showed their gallantry against the overwhelming forces of the Japanese Imperial army during the World War II;
