RESOLUTION REQUESTING THE MUNICIPAL MAYOR TO INSTALL THE MUNICIPAL HALL AND OTHER PUBLIC BUILDINGS AND STRUCTURES WITH FIRE SAFETY DEVICES OF FIRE EXTINGUISHERS FOR THE SAFETY OF PERSONS, PROPERTIES, DOCUMENTS AND RECORDS OF THE MUNICIPALITY

WHEREAS, public safety and accountability of public records, properties and documents are the major concerns of the municipality;

WHEREAS, there were already cases and incidents of fire involving public properties and structures, vital documents and records which were lost and destroyed due to lack of fire safety devices and preparation which amount to millions of pesos of damages;

NOW THEREFORE, on motion of Hon. Rexfel G. Trivilegio, Chairman, S.B. Committee on General Services, Social Welfare, Senior Citizens and Local & International Relations and duly seconded by Hon. Ma. Bernardita Taasan.

RESOLVED AS IT IS HEREBY RESOLVED, to request the Municipal Mayor, Hon. Myrna M. Torres to install the Municipal Hall and other Public Structures with fire safety devices of fire extinguishers for the safety of persons, properties, documents and records of the municipality,

RESOLVED FURTHER, to furnish a copy of this resolution to the office of the Municipal Mayor, Tigbauan, Iloilo for her information and appropriate action.
