RESOLUTION NO. 98-062

RESOLUTION APPROVING THE RECOMMENDED FEES BY THE TIGBAUAN HEALTH BOARD TO COVER FUEL AND OIL EXPENSES FOR THE USE OF THE MUNICIPALITY'S AMBULANCE

WHEREAS, the ambulance was donated by the Philippine Charity Sweepstakes to the Municipality of Tigbauan during this year 1998 and it was received by the Municipal Government in 1998;

WHEREAS, this year 1998 budget, there was no appropriation for gasoline, fuel, repair and maintenance for the said ambulance;

WHEREAS, there was a directive from the National Government that Local Government Unit shall observe strictly the austerity measure;

WHEREAS, in order that the Municipality's Ambulance could serve more effectively to the public, we appeal to the people to cooperate fully in the use of said vehicles; it shall observe strictly the guidelines as recommended by the Local Health Board on the fuel and oil expenses;

WHEREAS, the recommended fees by the Tigbauan Health Board to cover oil and fuel expenses to be collected from the non-indigent members of the family of the patient transported, shall be the following:

1. Tigbauan to Guimbal	-	P30.00
2. Guimbal to Iloilo	-	P150.00
3. Tigbauan to Iloilo	-	P100.00

NOW THEREFORE, on motion of Hon. Cecilia Garrido, Chairman, S.B. Committee on Health and Sanitation and duly seconded by Hon. Ma. Bernardita Taasan and Hon. Cornelia Terue, Be It

RESOLVED, AS IT IS HEREBY RESOLVED, to approve the recommended fees by the Tigbauan Health Board to cover fuel and oil expenses for the use of the Municipality's Ambulance.
