RESOLUTION REALIGNING THE AMOUNT OF ONE HUNDRED SEVENTY THREE THOUSAND ANE HUNDRED NINETY FIVE PESOS (P173,195.00) PREVIOUSLY INTENDED FOR THE PROJECTS UNDER THE PROGRAM OF HUMAN ECOLOGICAL SECURITY 20% IRA DEVELOPMENT FUND OF THIS MUNICIPALITY, TO THE HUMAN RESOURCE DEVELOPMENT SECTOR UNDER ADMINISTRATION COMPONENT PROGRAM (OFFICE AUTOMATION)

WHEREAS, the Provincial Government of Iloilo and the Municipal Government of Tigbauan is currently working on the improvement of collections on Real Property Taxes;

WHEREAS, it is important that computerization of Real Property assessment shall be fully implemented for effective and efficient Real Property Tax Collection;

WHEREAS, the expenses that will be incurred the said computerization will amount to One Hundred Thirty thousand Pesos (P130,000.00) more o less;

WHEREAS, the Provincial Government of Iloilo offered to help the Municipality of Tigbauan, on the said project such that the municipal government shall put-up a counterpart of Seventy One Thousand Pesos (P71,000.00) and the rest shall be paid by the provincial government of Iloilo;

WHERAS, other offices in the Municipal Government of Tigbauan also need to be computerized in order to improve the efficiency of service they offered to the citizenry;

WHEREAS, the previously mentioned projects where the appropriations were realigned shall not be effective because appropriation had been provided in the 1998 budget;
