Resolution No. 98-082

RESOLUTION REQUESTING HONORABLE ARTHUR DEFENSOR, GOVERNOR, PROVINCE OF ILOILO TO SUSPEND TEMPORARILY, THE PROCESSING OF NEW PERMITS (IF THERE'S ANY) TO EXTRACT SAND, GRAVEL AND OTHER QUARRY RESOURCES IN THE TERRITORIAL JURISDICTION OF TIGBAUAN, ILOILO

WHEREAS, Section 447 of the Local Government Code of 1991, RA 7160 states that the Sangguniang Bayan, as the Legislative Body of the Municipality, shall x-x-x approved resolutions x-x-x for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this Code and shall: adopt measures to protect the inhabitants of the municipality from harmful effects of man-made or natural disasters and calamities and to protect the environment and other activities which result to ecological imbalance;

WHEREAS, it was found out by the Committee on environmental Protection x-x-x-x-x that Sibalom River in the territorial jurisdiction of Tigbauan, Iloilo is (now) in dire need to be rehabilitated because of the destruction made by irresponsible extractors;

WHEREAS, suspension in the processing of new permits (if there are any) shall only be temporary until the area is rehabilitated;

WHEREAS, the existing permittees shall continue to extract sand, gravel and other quarry resources in their approved applied areas until the approved number of cubic meters of sand, gravel and other quarry resources shall be taken or exhausted/consummated ;

NOW, THEREFORE, on motion of Hon. Rexfel G. Trivilegio, Chairman, Committee on environmental Protection, and duly seconded by Hon. George T. Tribunal,

RESOLVED, to request Hon. Arthur Defensor, governor, Province of Iloilo to suspend temporarily the processing of new permits (if there's any) to extract sand, gravel and other quarry resources in the territorial jurisdiction of Tigbauan, Iloilo,

RESOLVED FURTHER, to furnish copies of this resolution to Governor Arthur Defensor, Province of Iloilo, the Office of the DENR, Iloilo City and to all concerned for their information and/or appropriate action.
