RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A LEASE AGREEMENT WITH THE CONCESSIONERS OF THE MUNICIPAL FISHING ZONES PARTICULARLY THE PALUPADAN SITE IN THE MUNICIPAL WATERS OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, it was found out by the Chairman Committee on Agriculture, Fisheries and Cooperatives that structures are being erected at the Palupadan Fishing Zone;

WHEREAS, the Chairman, committee on Agriculture, Fisheries and Cooperatives revealed his findings to the Municipal Treasurer to confirm if contracts had been executed by the parties concerned;

WHEREAS, according to the Municipal Treasurer no binding contracts had been executed between the palupadan operators/concessioners and in view thereof, the Chairman, Committee on Agriculture, Fisheries and Cooperatives called the attention of these operators/concessioners responsible for the act;

WHEREAS, the operators/concessioners above-cited submitted themselves for the wrongdoing to the Chairman, committee on Agriculture, Fisheries and Cooperatives and they promise to comply with the requirements of the municipal government regarding the matters;

WHEREAS, in order to protect the interest of the municipality and to generate revenues from the said fishing site, the Sangguniang Bayan has come up with an idea of giving authority to the Municipal Mayor to enter into a lease agreement between the operators/concessioners concerned and the municipality;

NOW, THEREFORE, on motion of Hon. Richard T. Tenerife, Chairman, Committee on Agriculture, Fisheries and Cooperatives and duly seconded by Hon. Rexfel G. Trivilegio, Be It

RESOLVED, to authorize the Municipal Mayor to enter into a lease agreement with the concessioners of the municipal fishing zones particularly the palupadan site in the municipal waters of the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward copies of this resolution to Hon. Myrna M. Torres, Municipal Mayor and to all concerned for their information and/or appropriate action
