Resolution No. 99-026

RESOLUTION CREATING AN AD HOC COMMITTEE TO CONDUCT AN INVESTIGATION ON THE DEMOLITION OF THE HEALTH CENTER AT SITIO BOLOCAWE, BARANGAY BAGACAY, TIGBAUAN, ILOILO

WHEREAS, it was found out that the health center owned by the Government at sitio Bolocawe, Barangay Bagacay, Tigbauan, Iloilo was demolished by an unknown person sometime in the month of February 1999;

WHEREAS, there are procedures to be followed in the destruction or demolition of the government properties particularly provided under Section 502 of the government auditing rules and regulations and Section 379 of the Local Government Code of 1991;

WHEREAS, said Section 502. Destruction or sale of unserviceable property states:

“When government property has become unserviceable for any cause, or is no longer needed, it shall, upon application of the officer accountable therefor, be inspected by the head of the agency or his duly authorized representative in the presence of the Auditor concerned and, if found valueless or unsalable, it may be destroyed in their presence. If found to be valuable, it may be sold at public auction to be highest bidder under the supervision of the proper committee on award or similar body in the presence of the auditor or other duly authorized representative of the Commission on Audit”

WHEREAS, said Section 379, RA 7160 states:

“In the local government units, when property of any local government unit has become unserviceable for any cause or is no longer needed, it shall, upon application of the officer accountable therefor, be inspected and appraised by the provincial, city or municipal

auditor, as the case maybe, or his duly authorized representative or that of the Commission on Audit and, if found valueless or unusable, it shall be destroyed in the presence of the inspecting officer.

If found valuable, the same shall be sold at public auction to the highest bidder under the supervision of the committee on awards and in the presence of the provincial, city or municipal auditor or his duly authorized representative. Notice of the public auction shall be posted in at least three (3) public accessible and conspicuous places, and if the acquisition cost exceeds one hundred thousand pesos (P100,000.00) in the case of the province or city and fifty thousand (P50,000.00) in the case of municipalities, notice of auction shall be published at least two (2) times within a reasonable period in a newspaper of general circulation in the locality”

WHEREAS, with this kind of irregularity in the demolition of the said health center, an investigation is deemed proper to find the facts or truth on the matter;

WHEREAS, an AD HOC COMMITTEE is hereby created to conduct investigation on the matter to be composed of the following:

ABC President or her authorized representative</li></ol>

NOW, THEREFORE, upon motion by Hon. Cecilia T. Garrido, Chairman, Committee on Health and Sanitation and duly seconded by Hon. George T. Tribunal,

RESOLVED, to create an AD HOC COMMITTEE to conduct an investigation on the demolition of the Health Center at Sitio Bolocawe, Barangay Bagacay, Tigbauan, Iloilo,

RESOLVED FURTHER, to furnish copies of this resolution to all concerned for their information and/or appropriate action.
