Resolution No. 99-028

RESOLUTION REQUESTING GOVERNOR ARTHUR DEFENSOR, PROVINCE OF ILOILO TO OPEN THE QUARRY OPERATION AT THE SIBALOM RIVER, TO ISSUE PERMIT AND FOR THE DENR TO ISSUE ENVIRONMENTAL COMPLIANCE CERTIFICATE

WHEREAS, the Sangguniang Bayan of Tigbauan, Iloilo had passed Resolution No. 98-082, last November 17, 1998 requesting the Provincial Governor of Iloilo, Arthur Defensor to suspend temporarily the processing of new permit (if there's any) to extract sand, gravel and other quarry resources in the territorial jurisdiction, this municipality because of the consistent destruction of the environment especially at Sibalom River, particularly in the ricefield;

WHEREAS, in response to the above-mentioned request, Governor Defensor instructed his personnel to evaluate the area at Sibalom River at Barangay Cordova Sur and Norte and Barangay Barosong, this municipality;

WHEREAS, the evaluation report by the PENRO evaluating team conducted at Sibalom River of the above-mentioned barangays last January 11, 1999 showed that siltation and thick deposits of unconsolidated materials have invaded the full width of the riverbed causing to obstruct the smooth flow of the water;

WHEREAS, in order to eliminate the obstruction, it is recommended that the unconsolidated materials shall be removed and cleared up so that the flow of water during heavy rains will run smoothly at the riverbed;

WHEREAS, it is also recommended by the PENRO evaluating team to open the quarry concession and to allow the extraction of sand and gravel and other quarry resources at the Sibalom River by dredging and strengthening the course of the river in order to avoid further soil erosion at the riverbank and destruction, particularly of the ricefield;

WHEREAS, the area stretching from NIA Intake diversion canal to the connecting barangay road shall also be opened up;

NOW, THEREFORE, on motion of Honorable Rexfel G. Trivilegio, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Honorable Cornelia Teruel and Honorable Ramonita Alcala,

WHEREAS, to request Governor Arthur Defensor, Province of Iloilo to open the quarry operation at the Sibalom River, to issue permit and for the DENR to issue Environmental Compliance Certificate,

RESOLVED FURTHER, to forward copies of this Resolution to Hon. Arthur Defensor, Province of Iloilo, to the Office of the DENR and PENRO, Iloilo City and to all concerned for their information and/or appropriate action.
