RESOLUTION ESTABLISHING POLICE ASSISTANCE CENTERS ALONG THE HIGHWAY OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO, SPECIFICALLY AT BARANGAYS BARROC, NAMOCON AND BUYU-AN

WHEREAS, Barangays Barroc, Atabayan, Baguingin, Namocon, parara Norte and Sur and Buyu-an are now thickly populated;

WHEREAS, it was observed that the traffic rules and regulations of the Municipality of Tigbauan are not strictly enforced;

WHEREAS, based on the record of the PNP-Tigbauan, there were so many vehicular accidents that happened already;

WHEREAS, in order to minimize vehicular accidents, the police assistance centers shall be established;

WHEREAS, the outpost shall be manned by the PNP- personnel with the assistance of the barangay tanods of the concerned barangays;

NOW, THEREFORE, upon motion of Honorable George Tribunal , Chairman, Committee on Peace and Order and Public Safety and duly seconded by Hon. Ramonita Alcala, Be It,

RESOLVED, to establish police assistance centers along the highways of the Municipality of Tigbauan, Province of Iloilo, specifically at Barangays Barroc, Namocon, and Buyu-an,

RESOLVED FURTHER, to furnish a copy of this resolution to Police Senior Inspector Cezar F. Fantonalgo, Chief of Police Tigbauan, Iloilo for his information and/or appropriate action.
