RESOLUTION CREATING THE “AD HOC COMMITTEE” TO CONDUCT AN IVNESTIGATION ON THE ADMINISTRATIVE COMPLAINT FILED BY MRS. SUSAN TORRENTO AGAINST BARANGAY CAPTAIN ROGELIO TAMAYO OF BARANGAY PARARA SUR, TIGBAUAN, ILOILO

WHEREAS, the creation of this Ad Hoc Committee (which is a fact-finding committee), is necessary in order to investigate the veracity of the truth on the administrative complaint filed by Mrs. Susan Torrento against barangay Captain Rogelio Tamayo;

WHEREAS, Mrs. Susan Torrento in her letter complaint alleges that Barangay Captain Rogelio Tamayo committed the following acts:

- a. “Abuse of authority, oppression and misconduct as provided in Section 60 of the Local Government Code;
- b. Grave threats as punished under Art. 282 of the Revised Penal Code;
- c. Violation of the norms of conduct as provided in Sec. 4, R.A. 6713, Code of Conduct and Ethical Standards for Public Officials etc.”

WHEREAS, in order that this matter will be properly investigated pursuant to Section 61 and Section 62 of the Local Government Code of 1991 it was consensusly agreed that this Ad Hoc shall be composed of the following:
