RESOLUTION ADOPTING SK RESOLUTION NO. 99-002 – DECLARING MARCH 21, 1999 AS THE SIMULTANEOUS SPECIAL ELECTION FOR THE FILLING UP OF VACANCIES OF SANGGUNIANG KABATAAN MEMBERS IN THE BARANGAY LEVEL OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, there are less than ten (10) out of Fifty Two (52) Barangays who have a complete set of Sangguniang Kabataan members;

WHEREAS, it is also a cause of an unsystematic project implementation and bogged down activities of the Sangguniang Kabataan Municipal Federation;

WHEREAS, the special election shall be funded from the 10% SK Fund of the respective barangays;

WHEREAS, the success and the performance of the SK Municipal Federation depend upon the active participation and cooperation of the Katipunan ng Kabataan and Sangguniang Kabataan Members in the Barangay Level;

NOW, THEREFORE, upon motion of Hon. Jonathan Torrato, President, PPSK and duly seconded by Hon. Ramonita Alcala,

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to adopt Resolution No. 99-002 – declaring March 21, 1999 as the simultaneous special election for the filling up of vacancies of the Sangguniang Kabataan members in the barangay level of the Municipality of Tigbauan, Province of Iloilo,
