RESOLUTION REQUESTING HIS EXCELLENCY PRESIDENT JOSEPH “ERAP” EJERCITO-ESTRADA FOR FINANCIAL ASSISTANCE OF ONE MILLION PESOS (P1M) FOR THE CONSTRUCTION AND MAINTENANCE OF THE BARANGAY ROAD CONNECTING BARANGAYS SUPA, CANSILAYAN AND BUYU-AN

WHEREAS, Barangay Cansilayan and Barangay Supa are more or less four (4) kilometers away from the Poblacion, Tigbauan, Iloilo;

WHEREAS, the abovementioned barangays are major sources of fresh fruits, vegetables, and other agricultural products of this municipality;

WHEREAS, it is very hard for the farmers of these barangays to transport their products to the poblacion and other neighboring municipalities due to the bad condition of the barangay road and bridge connecting these barangays to the national road;

WHEREAS, the municipal government and the barangays concerned lack the financial capability to construct and maintain the barangay road necessary for the effective and efficient delivery of services to the abovementioned barangays;

NOW, THEREFORE, on motion of Honorable Cecilia Garrido, Chairman, Committee on Health and Sanitation and duly seconded by Hon. Ma. Bernardita Taasan, Hon. George Tribunal and Hon. Jonathan Torrato,

RESOLVED, to request His Excellency President Joseph “Erap” Ejercito Estrada for financial assistance of One Million Pesos (P1M) for the construction and maintenance of the barangay road connecting Barangays Supa, Cansilayan and Buyu-an,

RESOLVED FURTHER, to furnish copies of this resolution to His Excellency President Joseph “Erap” Ejercito Estrada for his information and/or appropriate action.
