RESOLUTION AUTHORIZING MR. MANUEL T. TABALADA JR. OIC, OFFICE OF THE MUNICIPAL TREASURER, TIGBAUAN, ILOILO TO DEPOSIT, WITHDRAW AND DISBURSE FUNDS FOR THE OPERATION OF THE LOCAL GOVERNMENT UNIT OF THE MUNICIPALITY OF TIGBAUAN, ILOILO FROM THE PHILIPPINE NATIONAL BANK

WHEREAS, Hon. Mayor Myrna M. Torres, Municipal Mayor, Tigbauan, Iloilo issued Office Order No. 99-011 dated March 8, 1999, designating Mr. Manuel T. Tabalada Jr. Cashier I, As Officer-In-Charge (OIC) Office of the Municipal Treasurer effective immediately;

WHEREAS, Regional Director Demosthenes Querubin, of the Department of Finance, Bureau of Local Government Finance, Region VI, affirmed the designation of Mr. Manuel T. Tabalada Jr. as OIC, Office of the Municipal Treasurer, this municipality thru Regional Special Personnel Order No. 59-99, dated March 11, 1999;

WHEREAS, the designation of Mr. Manuel T. Tabalada Jr. as Officer-In-Charge (OIC), of the Office of the Municipal Treasurer involves supervision of the office and its manpower component and effective/efficient facilitation of the LGU's disbursements and payment of its statutory obligations and is therefore authorized to sign all pertinent documents relative to the treasury office operation;

NOW, THEREFORE, on motion of Hon. Ma. Bernardita T. Taasan, Chairman, Committee, S.B. Committee on Appropriation, Budget, Finance and Accounts and duly seconded by Hon. Richard Tenerife,

RESOLVED, to authorize Mr. Manuel T. Tabalada Jr. OIC, Office of the Municipal Treasurer, Tigbauan, Iloilo to Deposit, Withdraw and Disburse Funds for the operation of the Local Government Unit of the Municipality of Tigbauan, Iloilo from the Philippine National Bank,
