RESOLUTION DECLARING THE MONTH OF MAY AS BLOOD TYPING AND BLOOD LETTING MONTH OF THE
MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, having a schedule for certain activity such as blood typing and blood letting will give
preparation for NGO’s and other government agencies working together with the local government unit
of this municipality;

WHEREAS, the month of May was chosen as the blood typing and blood letting month for the
reason that the Parents are not so busy because their pupils/students are on school vacation;

WHEREAS, Tigbaueños staying in other places of the country and abroad usually spend their
vacation during this month;

WHEREAS, the month of May comes before June which is the start of the rainy season and
wherein epidemic of diseases like waterborne diseases and diseases caused by mosquitoes usually
occur;

WHEREAS, during the prevalence of these diseases cited above doctors recommend blood
transfusion in severe cases;

WHEREAS, a data bank on blood types and blood donations is very important for every
Tigbaueño especially when there is an urgent need for blood transfusion;

WHEREAS, the activity will mutually benefit the donor and the donee alike;

WHEREAS, the Sanggunian Members concerned of the health and welfare of the people, had come up of this idea to protect and save the life of the people during emergencies;
