Resolution No. 99-041

RESOLUTION INFORMING THE SANGGUNIANG BARANGAY OF BARANGAYS BITAS, NAMOCON, ATABAYAN, NAPNAPAN NORTE, BARANGAY 6(POBLACION), PARARA SUR, BUGASONGAN, TAN PAEL, CANSILAYAN, LINO BAYAN, BARANGAY 7(POBLACION), ISIAN, JAMOG, BARANGAY 5(POBLACION), SAN RAFAEL, PARARA NORTE, AND SERMON OF THE RESULT OF THE SANGGUNIANG BAYAN'S REVIEW OF THEIR 1999 ANNUAL BARANGAY BUDGET

WHEREAS, Section 333 of the 1991 Local Government Code provided that the Sangguniang Bayan is empowered to review the budgets approved by the Sangguniang Barangay, to ensure that provisions of the Code are complies with;

WHEREAS, during the review of the 1999 Annual Budgets of the above-mentioned Barangays by the Committee on Appropriation, Budget and Accounts, the Committee ensures that the said Barangay Budgets had been duly certified as to the correctness of the actual income for the last Calendar Year to the reasonable probability of collection of the estimated income for the Current Budget Year, by the Municipal Accountant, the OIC Municipal Treasurer and the Municipal Budget Officer;

WHEREAS, in view of the certification issued by the Municipal Accountant, Municipal Treasurer and Municipal Budget Officer, the Committee on Appropriation, Budget, Finance and Accounts recommended that the above-mentioned Annual Barngay Budgets shall be returned to the Sangguniang Barangays concerned for proper implementation, provided that the accountability shall be vested primarily in the Punong Barangays concerned;

WHEREAS, the Sangguniang Bayan of Tigbauan adopted the recommendation of the Committee on Appropriation, Budget, Finance and Accounts;

NOW, THEREFORE, on motion of Hon. George Tribunal, Vice-Chairman, Committee on Appropriation, Budget, Finance & Accounts and duly seconded by Hon. Cornelia Teruel, Hon. Cecilia Garrido and Hon. Ramonita Alcala,

RESOLVED, to inform the Sangguniang Barangay of Barangays Bitas, Namocon, Atabayan, Napnapan Norte, Barangay 6(Poblacion), Parara Sur, Bugasongan, Tan Pael, Cansilayan, Linobayan, Barangay 7(Poblacion), Isian, Jamog, Barangay 5(Poblacion), San Rafael, Parara Norte, and Sermon of the Result of the Sangguniang Bayan’s Review of their 1999 Annual Barangay Budget
