RESOLUTION FAVORABLY ENDORSING THE APPLICATION OF J. TORRES ENTERPRISES TO SECURE AN ECC (ENVIRONMENTAL COMPLIANCE CERTIFICATE) FROM THE DEPARTMENT OF ENVIRONMENTAL & NATURAL RESOURCES (DENR) TO OPERATE A KILN DRYING FACTORY AT BARANGAY TAN PAEL, TIGBAUAN, ILOILO

WHEREAS, J. Torres enterprises, owned and operated by Mr. Jaime Torres had acquired a parcel of land Barangay Tan Pael, Tigbauan, Iloilo for the operation of the kiln drying factory;

WHEREAS, the establishment of the kiln drying factory is beneficial to Barangay Tan Pael, Tigbauan, Iloilo, since it can generate opportunities on the part of the residents of Barangay Tan Pael and its neighboring barangays;
