WHEREAS, the PENRO, Province of Iloilo has conducted a survey on the status and condition of the Sibalom River in the Municipality of Tigbauan;

WHEREAS, large amount of sand deposits were found to obstruct the river resulting to the rerouting of the water;

WHEREAS, a temporary rehabilitation plan to allow the extraction of sand and gravel at the designated areas was recommended to help remove the amount of sand deposits that obstruct the waterway;

WHEREAS, the allowance of the extraction of sand and gravel shall economically enhance the source of living of the people in the barangay along the river and the considerable amount of taxes derived therefrom;

NOW, THEREFORE, on motion of Hon. Rexfel G. Trivilegio, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation, duly seconded by Hon. Rene Ledesma and Hon. Richard Tenerife;

RESOLVED, to request the PENRO, Province of Iloilo to issue permit and for the DENR, Region VI to issue Environmental Compliance Certificates to the said applicants to extract sand and gravel at the Sibalom River within the Territorial Jurisdiction of the Municipality of Tigbauan,

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Governor, Province of Iloilo, the DENR, Region VI, for their information and appropriate action and to all concerned for their information and guidance.
