RESOLUTION EARNESTLY REQUESTING FINANCIAL ASSISTANCE FROM HON. VICE GOVERNOR DEMY P. SONZA, PROVINCE OF ILOILO IN THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) FOR THE CONSTRUCTION OF FIVE (5) POLICE OUTPOSTS ALONG THE HIGHWAY, IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan has no police outposts along the highway;

WHEREAS, police outposts are very necessary especially in crime-prone areas and serve as a deterrent to crimes because of police visibility;

WHEREAS, the construction of police outposts will provide opportunity for the dispersal of the police from the headquarters into the streets where they are most needed;

WHEREAS, police visibility can lead to elimination of street and neighborhood crimes, like hold-ups and robberies and likewise quick and immediate response to incidents such as traffic violations, traffic accidents, illegal activities, etc;

NOW, THEREFORE, on motion of Hon. Remedios T. Torrato, Chairman, Committee on Games and Amusement and duly seconded by Hon. Ma. Bernardita T. Taasan,

RESOLVED, to earnestly request financial assistance from Hon. Vice Governor Demy P. Sonza, Province of Iloilo in the amount of Five Hundred Thousand Pesos (P500,000) for the construction of five (5) police outposts along the highway, in the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to furnish a copy of this resolution to Hon. Demy P. Sonza for his information and/or appropriate action.
