RESOLUTION EARNESTLY REQUESTING FINANCIAL ASSISTANCE FROM SENATOR JUAN FLAVIER IN THE  
AMOUNT OF THREE MILLION PESOS (P3,000,000.00) FOR THE CONSTRUCTION OF A LYING-IN CLINIC IN  
THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan is proposing to extend its lying-in clinic to  
accommodate additional number of patients;

WHEREAS, the lying-in clinic was at first intended for deliveries of pregnant women only  
especially during nighttime, however, because of the overcrowding of patients in both private and  
government hospitals during the prevalence of epidemic of dengue fever, it is utilized as an infirmary  
despite of limited facilities and resources just to accommodate patients from this town, especially the  
indigents;

WHEREAS, the municipal officials had come up with this idea to provide better health services to  
their constituents especially to the poor and the needy who can't afford the expensive cost of  
hospitalization in a private hospital;

WHEREAS, the municipal officials fervently hope that the good Senator, concerned of the health  
and welfare of the citizenry, will help us realize our dream of providing better health services and  
facilities to protect the health and welfare of the inhabitants;

NOW, THEREFORE, on motion of Hon. Cecilia T. Garrido, Chairman, Committee on Health and  
Sanitation and duly seconded by Hon. Cornelia T. Teruel,

RESOLVED, to earnestly request financial assistance from Senator Juan Flavier in the amount of Three Million Pesos (P3,000,000.00) for the construction of a lying-in clinic in the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to furnish a copy of this resolution to Senator Juan Flavier for his information and/or appropriate action.
