RESOLUTION EARNESTLY REQUESTING FINANCIAL ASSISTANCE FROM SENATOR FRANKLIN DRILON IN THE AMOUNT OF FIVE MILLION PESOS (P5,000,000.00) FOR THE REPAIR AND REHABILITATION OF THE TIGBAUAN PUBLIC MARKET IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Tigbauan Public Market was constructed during the 1950's yet and is now very dilapidated by age or use;

WHEREAS, the construction framework of the Tigbauan Public Market including its walls and roofs need to be repaired and rehabilitated to withstand the effects of bad weather especially during the rainy season;

WHEREAS, the lack of maintenance of the building and its premises due to limited sources of funds hastened the building's depreciation resulting to leaking roofs, torn or broken walls, defective drainage system, comfort rooms and water supply;

WHEREAS, the Tigbauan Public Market is considered one of the town's good sources of revenues however, the income derived or generated therefrom is just enough to maintain the salaries and other fringe benefits of the utility workers assigned thereat;

WHEREAS, the Municipal Government of Tigbauan, much to its desire to undertake the reconstruction of the Tigbauan Public Market, could not possibly make it unless it can have the resources or required financing;

WHEREAS, the Municipal Officials, to put into reality their dream of giving a better marketplace to their constituents, pin down their hopes for its realization on the good Senator

NOW, THEREFORE, on motion of Hon. Richard Tenerife, Chairman, Committee on Market and Slaughterhouse and duly seconded by Hon. Jonathan T. Torrato and Hon. Remedios T. Torrato,

RESOLVED, to earnestly request financial assistance from Senator Franklin Drilon in the amount of Five Million Pesos (P5,000,000.00) for the repair and rehabilitation of the Tigbauan Public Market in the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to furnish a copy of this resolution to Senator Franklin Drilon for his information and/or appropriate action.
