RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE SENATOR AQUILINE PIMENTEL JR. FOR
THE CONSTRUCTION OF THE MUNICIPAL ANNEX BUILDING AND IMPROVEMENT AND REPAIR OF THE
MUNICIPAL HALL IN THE AMOUNT OF FIVE MILLION PESOS (P 5,000,000.00) IN THE MUNICIPALITY OF
TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan Provinince of Iloilo, a 4th class municipality and with a
distance of twenty two (22) kilometers from the City of Iloilo, is considered as one of the fastest growing
municipalities in the province and its strategic location in rural development;

WHEREAS, a Municipal hall was inaugurated on March 8, 1960, and since then only a few
improvements and repairs were made because of financial constraints;

WHEREAS, because of the rising demand for quality and effective public service together with
the devolution to the local government of some of the National Agencies, there is a need for additional
structures to accommodate these offices and to improve a workable condition among the offices in our
Municipal hall;

NOW, THEREFORE, on motion of Hon. Geore Tribunal, Chairman, Committee on Infrastructure,
Transportation, Communication and public Utilities and duly seconded by Hon. Cecilia T. Garrido,

RESOLVED, AS IT IS HEREBY RESOLVE, to request financial assistance from Senator Aquilino Pimentel Jr. for the construction of the Municipal annex Building and improvement and repair of the municipal Hall in the amount of five million pesos (P5,000,000,000.00) in the Municipality of Tigbauan, province of Iloilo,

RESOLVED FURTHER, to forward a copy of this resolution to Senator Aquillino Pimentel Jr. for his information and favorable action.
