RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR AND THE OIC, OFFICE OF THE MUNICIPAL  
TREASURER TO OPEN A TRUST ACCOUNT PREFERABLY IN ANY GOVERNMENT BANK FOR THE PURPOSE  
OF DEPOSITING THE P1...33 MILLION AS COST OF LGU-DPWH COST SHARING INFRASTRUCTURE PROJECT

WHEREAS, the League of Municipalities of the Philippines (LMP) thru its national president,  
Honorable Mayor Jinggoy Estrada had signed a Memorandum Of Agreement (MOA) with the  
Department of Public Works and Highways (DPWH) last March 15, 1999 regarding the DPWH cost  
sharing program for the implementation of infrastructure projects and to promote rural development in  
the municipalities;

WHEREAS, the National Government, through the DBM had released the amount of P 1.54  
Billion for the purpose of allocating P 1 Million for each of the municipalities as its counterpart fund to  
implement such projects;

WHEREAS, to fully implement the DPWH-LGU Cost Sharing program, the Municipality shall  
provide funds as counterpart for the infrastructure projects

WHEREAS, in 1999 Municipal Annual Budget, the municipal government had an allocation of  
P400, 000.00 for the maintenance of municipal streets and drainage in the 1999 20% Development  
Fund;

WHEREAS, the amount needed by the LGU as a 4<sup>th</sup> class municipality is P 333,333.33 representing 25% of the total amount of P 1,333.333.00 for the implementation of the said project;

WHEREAS, the amount of P333,333.00 shall be transferred to a trust account to be maintained by the municipality for the purpose of implementing the DPWH-LGU Cost sharing projects;

NOW, THEREFORE, on motion of Hon. Ma. Bernadita T. Taasan, Chairman, Committee on appropriation, Budget, Finance and Accounts and duly seconded by Hon. Remedios T. Torrado, Hon. George T. Tribunal and Hon. Cecilia T. Garrido,

RESOLVED, to authorize the Municipal Mayor and the OIC, Office Of The Municipal Treasurer to open a trust account preferably in any government bank for the purpose of depositing the p1...33 million as cost of LGU-DPWH cost sharing infrastructure project,

RESOLVED FURTHER, to furnish copies of this resolution to Hon. Jinggoy E. Estrada, to the DPWH, to the Hon. Mayor Myrna M. Torres and to all concerned for their information, guidance and/or appropriate action.
