RESOLUTION EARNESTLY REQUESTING THE ROTARY INTERNATIONAL, THRU MR. WALTER UY, PRESIDENT
OF THE ROTARY CLUB OF ILOILO MIDTOWN, TO DONATE MEDICAL EQUIPMENT FOR LYING-IN-CLINIC IN
THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Rural health Unit annex Building in the Municipality of Tigbauan (established in
1996) is issued as a lying-in-clinic and intended for normal deliveries of pregnant women;

WHEREAS, last year (1998) it was noted that during the outbreak of dengue fever in the
Province of Iloilo, private and public hospitals in Iloilo City experienced the shortage of rooms brought
about by the great number of patients especially dengue patients;

WHEREAS, it was likewise noted that because of the excessive number of patients admitted in
the public hospitals some were made to stay in the alleyway;

WHEREAS, in order to temporarily address the problem, the municipal officials had come up
with the idea of expanding the services of the municipal health office thereby using the RHU Annex
building as an infirmary to accommodate dengue patients of this municipality, especially the poor and
the needy who can't afford the expensive cost of hospitalization in a private hospital;

WHEREAS, in order to equip the RHU with the desired laboratory equipment, the municipal officials thought of soliciting donations from civic organizations, specially the Rotary International, thru the Rotary Club of Iloilo Midtown, of the following needed equipment;

1. Hematocrit Centrifuge
2. Cell Counter
3. Pipette Shaker
4. RBC & WBC Pipettes
5. Hermatocrit Reader
6. Counting chamber

WHEREAS, the Municipal officials reiterate their sincerest appreciation and deep gratitude the Rotary Club of Iloilo Midtown for the successful eye and dental mission last may 24-31, 1999 in the Municipality of Tigbauan,

NOW, THEREFORE, on motion of Hon. Cecilia T. Garrido, Chairman, Committee on Health and Sanitation and duly seconded by Hon. Remedios T. Torrato,

RESOLVED, to earnestly requesti the rotary international, thru Mr. Walter Uy, President of the Rotary Club Of Iloilo Midtown, to donate medical equipment for lying-in-clinic in the Municipality Of Tigbauan, Province Of Iloilo,

RESOLVED FURTHER, to furnish copies of this resolution to the Rotary International President, thru Mr. Walter Uy, President of the Rotary Club Iloilo Midtown, to Honorable Mayor Myrna M.
