RESOLUTION EARNESTLY REQUESTING FINANCIAL ASSISTANCE FROM SENATOR ROBERT BARBERS IN THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (P400,000.00) FOR THE CONSTRUCTION OF FARM-TO-MARKET ROAD AT SITIO TABUC DANA0, BITAS, IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Sitio Tabuc Danao which is part of Barangay Bitas in the Municipality of Tigbauan, Province of Iloilo has a distance of more or less 1.5 kms. from the national road linking the towns of Tigbauan and Leon;

WHEREAS, Sitio Tabuc Danao has wide farmlands suited for agriculture;

WHEREAS, the residents thereat, mostly are farmers depend solely on farming as a means of livelihood;

WHEREAS, because of the absence of road in the area, the residents encountered several problems such as difficulty of bringing their patients to the hospital in case of emergency, difficulty on schoolchildren, commuters and specially to farmers in transporting their agricultural products to the market;

WHEREAS, the construction of the farm-to-market road of more or less 1.5 kms. is the most felt-need project of the people living in the area comprising of more or less 100 households;

WHEREAS, the barangay could not undertake the said project due to limited sources of funds;

WHEREAS, the putting up of farm-to-market road could make life easier especially to the residents and could accelerate economic progress thru increased revenues that will be generated from taxes on farm products;

WHEREAS, the populace pin down their hopes on the good Senator for the realization of their dream of having a road linking their place to the national road;

NOW, THEREFORE, on motion of Hon. Rene T. Ledesma, Chairman, Committee on Good Government, Public Ethics And Accountability and duly seconded by Hon. Richard Tenerife, Hon. Cecilia Garrido and Hon. Ramonita Alcala,


