RESOLUTION RATIFYING THE AUTHORITY OF THE MUNICIPAL MAYOR, HON. MYRNA M. TORRES TO SIGN
AN AMENDED MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE LAND BANK OF THE PHILIPPINES
(LBP) – MIAGAO AND THE LOCAL GOVERNMENT UNIT (LGU), TIGBAUAN, ILOILO

WHEREAS, Hon. Myrna M. Torres was elected as Municipal mayor last May 11, 1998, and
assumed office last July 1, 1998;

WHEREAS, the Municipal Government of Tigbauan represented by then Mayor Celso T. Ledesma
had a MOA with the LBP so that the municipal officials and employees can avail of a salary loan from the
said banking institution;

WHEREAS, as a requirement for the renewal of loans of the LGU officials and employees, the
new municipal mayor shall be the signatory to the amended MOA;

WHEREAS, the LBP – Miagao had some amendments presented to the MOA such that
employees can avail of salary loan for a maximum of P40,000 – for rank and file and P100,000 for
municipal officials;

NOW, THEREFORE, on motion of Hon. Ma. Bernadita T. Taasan, Chairman, Committee on
Appropriation, Budget, Finance and Accounts and duly seconded by Hon. Cecilia Garrido and Hon.
Ramonita Alcala,

RESOLVED, to ratify the authority of the Municipal Mayor, Hon. Myrna M. Torres to sign an amended Memorandum of Agreement (MOA) between the Land Bank of the Philippines (LBP) – Miagao and the Local Government Unit (LGU), Tigbauan, Iloilo.

RESOLVED FURTHER, to furnish copies of this resolution to Hon. Mayor Myrna M. Torres, and to the Land Bank of the Philippines – Miagao for their information and/or appropriate action.
