RESOLUTION REQUESTING HIS EXCELLENCY PRESIDENT JOSEPH “ERAP” ESTRADA, THRU HON. JINGGOY
ESTRADA, PRESIDENT, LMP, TO DONATE ONE (1) UNIT AMBULANCE FOR THE MUNICIPALITY OF
TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, during our Live-In Strategic Planning Workshop on LPP (LGU Performance Program)
we were informed that LGU’s can avail of the “AMBULANSA PARA SA MASA”;

WHEREAS, there is a need to request for an ambulance in order to equip the Rural health Unit
with another ambulance to answer the demands for health services for the populace;

WHEREAS, it was noted that because of the excessive number of patients brought to private and
public hospitals, ambulance is needed to serve the needs of the Municipal Emergency Clinic in Tigbauan,
Iloilo;

WHEREAS, the ambulance will be used during emergency cases per assessment of the Municipal
health Physician and likewise for non-emergency cases, such as fetching patients from the hospital back
to his/her house and for the private physician having emergency patients that need to be brought to the
hospital;

NOW, THEREFORE, on motion of Hon. Cecilia T. Garrido, Chairman, Committee on Health and
Sanitation and duly seconded by Hon. Ma. Bernadita T. Taasan,

RESOLVED, to request his Excellency President Joseph “Erap” Estrada, thru Hon. Jinggoy Estrada, President , LMP to donate one (1) unit ambulance for the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to furnish a copy of this resolution to His Excellency President Joseph “Erap” Estrada, thru Hon. Jinggoy Estrada, President, LMP, to the Assistant Municipal Health Officer, Dr. Josefa Monserate and to the Honorable Municipal mayor, Tigbauan, Iloilo, for their information, guidance and /or appropriate action.
