RESOLUTION FAVORABLY ENDORSING THE APPROVAL FOR LAND CONVERSION AND DEVELOPMENT OF
THE PROPERTY OF MR. LORETO GONZALES LOCATED AT BARANGAY DAPDAP, TIGBAUAN, ILOILO FROM
UPLAND TO IRRIGATED RICELAND AND REMOVING THE EXCESS ORDINARY EARTH MATERIALS THEREOF;

WHEREAS, subject lots, with Lot No. 10274 and Lot No. 10277, declared under the name of
Loreto Gonzales of Barangay Dapdap, Tigbauan, Iloilo, contain an estimated area of about Thirty Three
Thousand Ninety Seven (33, 097) square meters more or less;

WHEREAS, the property has become unproductive and not suited for upland farming because of
its terrain, soil and land structure;

WHEREAS, the owner of the property, Mr. Loreto Gonzales deems it fit to develop the property
and convert it into a rice field;

WHEREAS, the development of the land and removal of the excess ordinary earth, will make the
property more accessible for irrigation and increase its production and income;

NOW, THEREFORE, on motion of Hon. Rexfel G. Trivilegio, Chairman Committee on Housing,
Land Utilization, Zonification, Assessment and Expropriation, and duly seconded by Hon. George
Tribunal,

RESOLVED, AS IT IS HEREBY RESOLVED, to favorably indorse the approval for land conversion and development of the property of Mr. Loreto Gonzales, located at Barangay Dapdap, Tigbauan, Iloilo, from upland to irrigated rice land and removing the excess ordinary earth materials thereof,

RESOLVED FURTHER, to furnish copies of this resolution to the Office of the Provincial Governor, to the Provincial Environment and Natural Resources Office (PENRO) and other concerned government agencies.
