TORRES, IN BEHALF OF THE MUNICIPAL GOVERNMENT OF TIGBAUAN, ILOILOTO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL FOOD AUTHORITY (NFA) ILOILO CITY FOR A RICE LOAN ASSISTANCE DURING CALAMITIES CHARGEABLE AGAINST THE 5% CALAMITY FUND OF THE MUNICIPALITY'S 1999 ANNUAL BUDGET

WHEREAS, the National Food Authority (NFA) is the government agency charged with among others, ensuring the nation with adequate supply and distribution of grains;

RESOLVED, to authorize the Hon. Mayor Myrna M. Torres, in behalf of the Municipal government of Tigbauan, Iloilo to enter into a Memorandum of Agreement (MOA) with the National Food Authority (NFA) Iloilo City for a rice loan assistance during calamities chargeable against the 5% calamity fund of the Municipality's 1999 Annual Budget,
