RESOLUTION REQUESTING THE PENRO, PROVINCE OF ILOILO TO ISSUE PERMIT AND THE DENR, REGION VI TO ISSUE ENVIRONMENTAL COMPLIANCE CERTIFICATE TO MRS. ERNA SERVENTO TO EXTRACT SAND AND GRAVEL AT THE SIBALOM RIVER WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF TIGBAUAN

WHEREAS, the PENRO, Province of Iloilo had conducted a survey on the status and condition of the Sibalom River in the Municipality of Tigbauan;

WHEREAS, large amount of sand deposits were found to obstruct the river resulting to the rerouting of the river;

WHEREAS, a temporary rehabilitation plan to allow the extraction of sand and gravel at the designated areas was recommended to help remove the amount of sand deposits that obstruct the waterway;

WHEREAS, the allowance of the extraction of sand and gravel shall economically enhance the source of living of the people in the barangay along the river and the considerable amount of taxes derived therefrom;

NOW, THEREFORE, on motion of Hon. Rexfel Trivilegio, Chairman, Committee on Environmental Protection, Housing Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Ma. Bernadita Taasan, Hon. Cornelia Teruel and Hon. George Tribunal,

RESOLVED, to request the PENRO, Province of Iloilo to issue permit and the DENR, Region VI issue Environmental Compliance Certificate to MRS. Erma Servento to extract sand and gravel at the Sibalom River within the territorial jurisdiction of the Municipality of Tigbauan,

RESOLVED FURTHER, to furnish copies of this resolution to the Office of the Governor, Province of Iloilo, the DENR, Region VI, and to all concern for their information and guidance.
