RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HON. RENE VILLA, PRESIDENTIAL ASSISTANCE FOR WESTERN VISAYAS FOR THE GRAVELLING OF VARIOUS BARANGAY ROADS WITH THE TOTAL LENGTH / DISTANCE OF 44.897 KILOMETERS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, said barangay road in the Municipality of Tigbauan have an approximate total length/distance of 44.897 kms;

WHEREAS, the LGU of Tigbauan can hardly cope up with the finances incurred in the maintenance of such barangay roads;

WHEREAS, maintenance of access roads to the different barangays in the municipality is very important so that farmers can easily transport their products to the markets;

WHEREAS, thru the intercession and assistance of Hon. Rene Villa, Presidential assistance For Western Visayas, said various barangay roads, will now be improved;
