RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR OF TIGBAUAN, ILOILO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE CROP INSURANCE CORPORATION (PCIC), REGION VI, ILOILO CITY TO PARTICIPATE, AVAIL AND PUT-UP FARM CAPITAL PROTECTION FUND TO PAY CROP INSURANCE PREMIUMS OF RICE FARMERS IN TIGBAUAN, ILOILO

WHEREAS, the Philippine Crop Insurance Corporation has a program of extending crop insurance privileges to palay qualified farmers with the amount corresponding to the actual cost of production inputs on said farm;

WHEREAS, the Municipality of Tigbauan, Iloilo will initially set-up and operate a farm capital protection fund from which qualified farmers may borrow to pay crop insurance premiums;

WHEREAS, considering the significance in attaining this insurance program of the PCIC, to protect client/rice farmers from actual cost of production input due to calamities;

NOWTHEREFORE, on motion of Hon. Rexfel G. Trivilegio, Vice Chairman, Committee on Agriculture and Fisheries and duly seconded by Hon. Ma. Bernadita Taasan,

BE IT RESOLVED AS IT IS HEREBY RESOLVE, to authorize the Municipal mayor of Tigbauan, iloilo, to enter into a Memorandum of agreement (MOA) with the PCIC, Region VI, Iloilo City to participate, avail and put-up farm capital protection fund to pay crop insurance premiums of rice farmers in Tigbauan, Iloilo.

RESOLVED FURTHER, to forward copies of this resolution to Hon. Arthur Defensor, Governor province of Iloilo, Hon. Myrna M. Torres, Municipal Mayor, Tigbauan, Iloilo and to the Regional manager, Philippine Crop Insurance Corporation (PCIC) for their information and guidance.
