RESOLUTION EARNESTLY REQUESTING FINANCIAL ASSISTANCE FROM DIRECTOR ROMEO DE LA CRUZ, DIRECTOR, NATIONAL COMMISSION FOR CULTURE & ARTS IN THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) FOR THE CONSTRUCTION OF THE TIGBAUAN CULTURAL CENTER, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan which is located about 23 kilometers from the City of Iloilo is known for its historical origin and legacy;

WHEREAS, Tigbauan was the site of the First Jesuit Boarding School for Boys, the first educational center in the Philippines; the home of a regional fisheries research institution, the Aquaculture Department of the Southeast Asian Fisheries Development Center (SEAFDEC); the site of one of the earliest electric cooperatives established in the Philippines, the site of the Sibalom River Irrigation System implemented by the National Irrigation Administration; and the place where the American Liberation Forces landed on the 18th of March 1945 which led to the liberation of the Islands of Panay and Romblon;

WHEREAS, the construction of the Tigbauan Cultural Center will greatly benefit the people of the municipality;

WHEREAS, the cultural center will be a good venue for conferences, seminars and trainings and other functions to be hosted by both the government and non-government organizations and agencies;

WHEREAS, through this program, we may be able to preserve our people's history, culture and achievements as an inspiration of our future generation;

NOW, THEREFORE, on motion of Hon. Cornelia Teruel, Chairman, Committee on Education & culture, History and Civil Service, and duly seconded by Hon. Remedios Torrato, Hon. Ramonita Alcala and Hon. Jonathan Torrato,

RESOLVED, AS IT IS HEREBY RESOLVED, to earnestly request financial assistance from Director Romeo de la Cruz, Director National Commission for Culture & Arts in the amount of one million pesos (P1,000,000.00) for the construction of the Tigbauan Cultural Center, Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to furnish copies of this resolution to the Office of Director Romeo de la Cruz for his information and favorable action and to Hon. Mayor Myrna M. Torres for her information and guidance.
