RESOLUTION ADOPTING ALL SPORTS ASSOCIATIONS IN THE MUNICIPALITY OF TIGBAUAN AND
ACCREDITING SAID SPORTS ASSOCIATIONS TO THE TIGBAUAN SPORTS COUNCIL AS THE MAIN BODY-IN –
CHARGE FOR YOUTH AND SPORTS DEVELOPMENT

WHEREAS, the Municipality of Tigbauan under Executive Order No. 99-12 has created the
Tigbauan Sports Council, composed of the Municipal Mayor, as Chairman, the local officials, and some
sports enthusiasts as members and aims to develop an effective and efficient youth and sports program
in the municipality;

WHEREAS, because of the rising demand for grassroots sports development under the tutelage
of the Philippine Sports Commission (PSC), the role of the Local Government Units (LGUs), the
Department of Interior and Local Government (DILG), the Department of Education, Culture and Sports
(DECS), and other National sports Association (NSAs) as the major agencies in-charge of sports, is to
enhance sports development in the country;

WHEREAS, the Municipal Government in its desire to develop athletes from the grassroots level,
the out-of-school youths, and the promotion of the local sports associations, come into agreement with
the government program of “Batang Pinoy” and “Philippine Youth Games” which begins to develop
sports at the early stage of a boy;

NOW, THEREFORE, on motion of Hon. Rexfel Trivilegio, Chairman, Committee on environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. George Tribunal and Hon. Jonathan Torrato;

RESOLVED, AS IT IS HEREBY RESOLVED, to adopt all sports associations in the Municipality of Tigbauan and accrediting said sports associations to the Tigbauan Sports Council as the main body in-charge for youth and sports development,

RESOLVED FURTHER, to furnish copies of this resolution to the Provincial Governor, the Division Superintendent of Schools, Province of Iloilo, the District Supervisor and Secondary School Principals in the Municipality of Tigbauan, the Chairman of the Tigbauan Sports Council and all its members and the local municipal and barangay sports associations for their information and guidance.
