RESOLUTION REQUESTING THE FIRST ENGINEERING DISTRICT, DEPARTMENT OF PUBLIC WORKS AND
HIGHWAYS, PROVINCE OF ILOILO FOR THE REHABILITATION OF BARANGAY 1 (POBLACION) BARANGAY
BUENAVISTA-DORONG-AN JUNCTION ROAD, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Barangay Buenavista – Dorong-an Road, a farm-to-market road stretches
about 1 kilometer and connects Barangays Buenavista-Dorong-an, Municipality of Tigbauan, Iloilo;

WHEREAS, the said road is considered as the route of agricultural products and other industries
produced by the farmers situated in the area, and marketed in the Municipality of Tigbauan, Leon,
Alimodian, San Miguel, the City of Iloilo and other adjacent municipalities in the province;

WHEREAS, because of lack of road accessibility , unfavorable road condition and high cost of
transportation the government suffers much of the losses hence the opportunity of delivering the basic
government services to the said community is greatly hampered/affected;

WHEREAS, the construction of this junction road will enhance the delivery of the farm products
and other industries of the farmers in the said community;

NOW, THEREFORE, on motion of Hon. Rexfel Trivilegio, Chairman, Committee on Environmental
Protection, Housing, Land utilization, Zonification, Assessment and Expropriation and duly seconded by
Hon. George Tribunal and Hon. Jonathan Torrato,

RESOLVED, AS IT IS HEREBY RESOLVED, to request the First Engineering District, Department of Public Works and Highways, Province of Iloilo for the rehabilitation of Barangay Buenavista- Dorong-an junction Road, Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to furnish copies of this resolution to the First Engineering District Engineer, Department of Public Works and Highways , Province of Iloilo and other concerned government agencies and benefactors for their information and/or appropriate action and to Hon. Mayor Myrna M. Torres for her information and guidance.
