RESOLUTION STRONGLY CONDEMNING MR. OSCAR GARIN, FORMER CONGRESSMAN, FIRST DISTRICT, ILOILO FOR SLAPPING AND MANHANDLING OF HON. RICARDO GENTELIZO, PUNONG BARANGAY OF BARANGAY BUYUAN, TIGBAUAN, ILOILO ON SEPTEMBER 10, 1999, ALLEGEDLY DUE TO POLITICAL VINDICTIVENESS

WHEREAS, Punong Barangay Ricardo Gentilizo is a soft-spoken mild mannered, un-assuming, a very friendly gentlemen, and one of our most conscientious and dedicated barangay officials;

WHEREAS, in the evening of September 9, 1999, being the "bisperas" of the town fiesta of Guimbal, Iloilo, Punong Barangay Gentilizo was invited by his friend, Atty. Gamaliel Travina, (a Garin supporter) at RACSO's which owned by Mr. Oscar Garin;

WHEREAS, RACSO's is a public entertainment place which is open to the public, and which visitors are supposed t be welcome;

WHEREAS, when Mr. Oscar Garin saw Punong Barangay Ricardo Gentilizo, he (Garin) confronted Ricardo Gentilizo, and without giving him a chance to explain or reason out, he (Oscar garin) slappedand/or manhandled this poor barangay official;

WHEREAS, the only "fault" of Punong Barangay Ricardo Gentilizo was because he supported his townmate Mr. Jaime Torres during the last 1998 congressional election and Ninfa Garin (wife of Oscar) lost heavily in Brgy. Buyu-an;

WHEREAS, Punong Barangay Ricardo Gentilizosustained physical injuries and tat it was a one-sided attck because Gentilizo is a small frail-looking man, while Oscar Garin is big and a strong man;

WHEREAS, decent people in Tigbauan, as wel as everywhere in the province of Iloilo, are shocked by this alleged power-drunk violences against Punong Barangay Gentilizo of Barangay Buyu-an, because this barangay is the venue of the world-renowned South East Asian Fisheries Development Center (SEAFDEC), an international community where trainees from around the world converge, a prestigious place in the province;

WHEREAS, we decry and condemn this injury and injustice to Punong Barangay Gentilizo, because an injury to him is an injury to all baranagy officials nationwide;

NOWTHEREFORE, upon motion of Ma. Bernadita Taasan, Chairman, Committee on Rules, Ordinances, resolutions and Legal Matters and duly seconded by Hon. Cecilia Garrrido,

BE IT RESOLVED, AS WE HEREBY RESOLVE, to strongly condemn Mr. OscarGarin, former Congressman, First DDistrict of Iloilo, for slapping and manhandling Hon. Ricardo Gentilizo, Punong Barangay of Barangay Buyu-an, Tigbauan, Iloilo, on September 10, 1999 allegedly due to political vindictiveness
