RESOLUTION ALLOCATING THE AMOUNT OF TEN THOUSAND PESOS (P10, 000.00) TO DEFRAY THE EXPENSES INCURRED BY THE OFFICE OF THE MUNICIPAL AGRICULTURE IN CONNECTION WITH THE CAMPAIGN AGAINST THE FOOT AND MOUTH DISEASE (FMD) OUTBREAK IN THE PROVINCE OF ILOILO, CHARGEABLE AGAINST ANY AVAILABLE FUNDS

WHEREAS, the Province of Iloilo is now affected by the outbreak of the Food and Mouth Diseases;

WHEREAS, the Municipality of Tigbauan, is one of the municipalities in the Province of Iloilo which has a big livestock raising industry;

WHEREAS, the Office of the Municipal Agriculture has presented the problem of lack of funds to be used for the campaign against this FMD outbreak to protect the livestock industry of our municipality;

WHEREAS, all the expenses that will be incurred in said campaign, shall be subject to liquidation;

NOWHEREFORE, on motion of Hon. Richard Tenerife, Chairman, Committee on Agriculture & Fisheries and duly seconded by Hon. Jonathan Torrado,

RESOLVED, to allocate the amount of Ten Thousand Pesos (p10, 000.00) to defray the expenses incurred by the office of the municipal agriculture in connection with the campaign against the foot and mouth disease (FMD) outbreak in the province of Iloilo, chargeable against any available funds

RESOLVED FURTHER, to furnish copies of this resolution to the Municipal Mayor, Hon. Myrna M. Torres, to the Municipal Accountant, the Municipal Treasurer and to the Office of the Municipal Agriculture for their information and/or appropriate action.
