RESOLUTION FAVORABLY ENDORSING TO CONGRESSMAN GORGONIO UNDER OF THE HOUSE OF CONGRESS THE HEREIN ATTACHED BARANGAY LANAG RESOLUTION NO. 04, SERIES OF 1999 ENTITLED "RESOLUTION REQUESTING HON. CONGRESSMAN GORGONIO UNDE OF THE HOUSE OF CONGRESS TO EXTEND FINANCIAL ASSISTANCE OF THREE HUNDRED THOUSAND PESOS (P3000,000.00) FOR THE MAINTENANCE OF FARM TO MARKET ROAD FROM BARANGAY BINALIUAN MAYOR TO SITIO SAPA SAB-A " MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, there are fifty-two barangays comprising the Municipality of Tigbauan, Province of Iloilo and the residents are mostly farmers who derive their income from agriculture;

WHEREAS, the problem of the farmers is the lack of maintenance of farm-to-market roads (especially in the far-flung areas) which become impassable during the rainy days causing difficulty to the farmers in selling their agricultural products to the market;

WHEREAS, due to the lack of funds, the municipal government could maintain the farm-to-market road from Barangay Binaliuan mayor to sitio Sapa Sab-a with an estimated distance of three (3) kilometers;

WHEREAS, the maintenance of the aforementioned farm-to-market road will pave the way for the improvement of the life of the residents living thereat and also of the neighboring barangays;

NOWHEREFORE, on motion of Hon. George Tribunal, Chairman, Committee on Infrastructure, Transportation and Public Utilities and duly seconded by Hon. Ramonita Alcala and Hon. Jonathan Torrato,

RESOLVED, to favorably endorse to Congressman Gorgonio Unde of the House of Congress the hereinattached Barangay Lanag Resolution No. 04, series of 1999 entitled "Resolution requesting Hon. Congressman Gorgonio Unde of the House of Congress to extend financial assistance of three hundred thousand pesos (P3000,000.00) for the maintenance of farm to market road from Barangay Binaliuhan Mayor to Sitio Sapa Sab-a" Municipality of Tigbauan, Province of Iloilo

RESOLVED FURTHER, to furnish copies of this Resolution to Congressman Gorgonio Unde, of the House of Congress for his information and favourable action and Mr. Robert T.
