RESOLUTION REQUESTING THE NATIONAL POWER CORPORATION (NPC) TO RETAIN THE POWER BARGE
IN ITS PRESENT SITE AT LAPUZ, LAPAZ, ILOILO CITY

WHEREAS, the NPC Power Barge supplies the large percentage of power for ILECO I, ILECO II,
GEMILCO and ANTECO;

WHEREAS, the relocation of the Power Barge from Lapuz, Lapaz, Iloilo City to other places can
greatly affect the power generation needed by ILECO consumers;

WHEREAS, the Southern Municipalities of the Province of Iloilo experience frequent brown outs
due to insufficient power supply;

NOWTHEREFORE, on motion of Hon. Rexfel Trivilegio, Vice Chairman, Committee on Agriculture,
Fisheries and Cooperatives and duly seconded by Hon. Remedios Torrato, Hon. Cecilia Garrido and Hon.
Jonathan Torrato.
