RESOLUTION REQUESTING FINANCIAL SUPPORT IN THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) FROM SECRETARY LITO BANAYO, SECRETARY OF PHILIPPINE TOURISM AUTHORITY FOR THE DEVELOPMENT AND BEAUTIFICATION OF THE TOWN PLAZA, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan which is only twenty two (22) kilometers away from the city and where SEAFDEC and ILECO are located is a ranking tourist attraction municipality in the province of Iloilo;

WHEREAS, sad to say the public plaza of this municipality is not attractive and beautiful as compared to the adjoining municipalities, like the Municipalities of Oton and Guimbal which have multipurpose gyms merged into their plaza beautification (for the staging of cultural and tourist-oriented presentations, stage plays and/or drama's), and other structure;

WHEREAS, the Municipal Government of Tigbauan had undertaken the initial construction of the plaza stage but until now is unfinished;

WHEREAS, the improvement and beautification of the public plaza with appropriate landscaping had been desired especially by the present administration;

WHEREAS, due to financial constraints by reason of devolution, the Municipal Government as of the moment could not afford to finance for the completion of the plaza stage and the implementation of the development plans and beautification projects for the plaza;

WHEREAS, the local officials of this municipality and their constituents would be very happy and grateful, if generous officials like Secretary Lito Banayo could give substantial financial assistance for such projects;

NOWHEREFORE, on motion of Hon. George Tribunal, Chairman, committee on Infrastructure, transportation and Public Utilities and duly seconded by Hon. Ma. Bernadita Taasan and Hon. Ramonita T. Alcala,

RESOLVED, to request financial support in the amount of Five Hundred Thousand Pesos (P5000,000.00) from Secretary Lito Banayo, Secretary of Philippine Authority for the development and beautification of the town plaza, Municipality of Tigbauan, Province of Iloilo.

RESOLVED FURTHER, to furnish copies of this Resolution to Secretary Lito Banayo, for his information and favourable action and to Hon. Mayor Myrna M. Torres for her information and guidance.
