RESOLUTION GRANTING AUTHORITY TO MAYOR MYRNA M. TORRES, MUNICIPAL MAYOR, MUNICIPALITY OF TIGBAUAN, ILOILO TO ENTER INTO A CONTRACT OF LEASE WITH MR. ERNESTO TAYHUPON OF BARANGAY BAGUINGIN , TIGBAUAN, ILOILO FOR THE MUNICIPAL FISHING ZONE KNOWN AS THE “PALUPADAN” AREA COVERING FROM THE PERPENDICULAR SHORELINE OF THE MUNICIPAL BOUNDARY OF OTON AND TIGBAUAN, SPECIALLY FROM BARANGAY BARROC UP TO NAMOCON, TIGBAUAN, ILOILO

WHEREAS, the Municipality of Tigbauan, Iloilo had called for the bidding of the Municipal Fishing Zone for “Palupadan” fishing area scheduled last October 15, 1999;

WHEREAS, there was a failure of bidding because no bidder was able to submit their sealed bit;

WHEREAS, because of the failure of bidding, a negotiated contract of lease shall be made in favor of Mr. Ernesto Tayhupon of Barangay Baguingin, Tigbauan, Iloilo in the amount of Forty Thousand Pesos (P40,000.00), for a term of one year renewable every year thereafter;

WHEREAS, the amount of lease should be paid in cash by the lessee upon signing of the contract of lease;

NOWTHEREFORE, on motion of Hon. Rexfel G. Trivilegio, Chairma, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment, and Expropriation and duly seconded by Hon. Ma. Bernadita Taasan,

RESOLVED, AS IT IS HEREBY RESOLVED, to grant authority to Mayor Myrna M. Torres, Municipal Mayor, Municipality of Tigbauan, Iloilo to enter into a contract of lease with Mr. Ernesto Tayhupon of Barangay Baguingin, Tigbauan, Iloilo for the Municipal fishing zone known as the “Palupadan” Area covering from the Perpendicular shoreline of the Municipal boundary of Oton and Tigbauan, specifically from Barangay Barroc up to Barangay Namocon, Tigbauan, Iloilo

RESOLVED FURTHER, to furnish copies of this Resolution to Mr. Ernesto Tayhupon, the Office of the Municipal treasurer, to Hon. Mayor Myrna M. Torres and to all concerned government agencies and instrumentalities for their information and guidance
