RESOLUTION REALIGNING THE AMOUNT OF NINE THOUSAND TWENTY NINE PESOS (P9,029.00) UNDER THE MAINTENANCE AND OTHER OPERATING EXPENSES ITEMS OF THE SANGGUNIANG BAYAN BUDGET FROM REPAIR AND MAINTENANCE – GOVERNMENT FACILITIES – P6,044; ADVERTISING & PUBLICATION EXPENSES – P985.00; AND TAXES, FEES AND DUES – P2,000.00 TO TRAVELLING EXPENSES, ALSO UNDER THE MAINTENANCE AND OTHER OPERATING EXPENSES ITEM, OFFICE OF THE SANGGUNIANG BAYAN BUDGET, TIGBAUAN, ILOILO

WHEREAS, the certification of the Municipal accountant issued on the 27th day of December 1999 states that the balances of appropriations under the MOOE item of the Sangguniang bayan Budget has a total of P9,029.00 consisting of P6,044.00 from Repair and Maintenance - Government facilities; P985.00 from Advertising & Publication Expenses and P2,000.00 from Taxes, Fees and Dues;

WHEREAS, because of the unexpected expenditures of the Sangguniang bayan during the Lakbay Aral, the limited budget on Travelling Expenses of the S.B. was exhausted;

WHEREAS, there are still pending claims for Travelling Expenses by the S. B Members and staff notwithstanding other expenses for the operation of the S. B Office;

WHEREAS, there is a need to realign the amount of P9,029.00 to defray expenses officially incurred by the municipal officials and staff of the S.B. office during their official travel and for other expenses for the operation of the S.B Office;

NOWTHEREFORE, on motion of Hon. George T. Tribunal, Vice Chairman, committee on Budget, appropriations Finnance & Accounts and duly seconded by Hon. Cornelia T. teruel and Hon. Cecilia T. Garrido,

RESOLVED, to realign the Amount of Nine Thousand Twenty Nine pesos (P9.029.00) under the MOOE item of the Sangguniang bayan Budget From Repair and Maintenance – Government facilities - P6,044.00; Advertising & Publications Expenses – P985.00; and taxes, Fees and dues – P2,000.00 to Travelling Expenses, also under the MOOE item, Office of the Sangguniang Bayan Budget, Tigbauan,Iloilo,

RESOLVED FURTHER, to furnish copies of this Resolution to the Municipal Budget officer, to the Municipal Accountant, to the OIC Municipal Treasurer and to hon. Mayor Myrna Montealegre-Torres, for their information and guidance.
