WHEREAS, Mrs. Edna Tamisan has been serving this municipality as Collection Agent of the BIR for several months and as such she has already established a good rapport with the taxpayer of Tigbauan;

NOWTHEREFORE, on motion of Honorable Cecilia T. Garrido and duly seconded by Hon. Richard Tenerife and Hon. George Tribunal,

RESOLVED, to request the Revenue District Officer, RDO No. 74, Bureau of Internal revenue, Iloilo City, to assign a Revenue Officer as the permanent Collection agent for the Local Government Unit of Tigbauan, Iloilo;
