RESOLUTION REQUESTING FINANCIAL ASSISATNCE IN THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1, 5000.00) FROM THE HON SENATOR BLAS OPLE FOR THE CONTSRCUTION OF BAGUINGIN SITIO LINO-FLORES TO NAPNAPAN ROAD, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the barangay Baguingin Sitio Lino-Flores to Napnapan road, a farm to market road, stretches about four (4) kilometers and connects the Barangays of Baguingin and Napnapan, Municipality of Tigbauan, Iloilo;

WHEREAS, the sad road is considered as the route of agricultural products and other industries produced by the farmers situated in the area and marketed in the Municipalities of Tigbauan, Leon, Alimodian, San Miguel, the City of Iloilo and other adjacent municipalities in the province;

WHEREAS, due to financial constraints, the Municipality of Tigbauan has no available funds to finance the construction of said road;

WHEREAS, because of the prevailing unfavorable road condition and high cost of transportation, the government suffers much of the loss, hence, the delivery of the basic government services to the said community is greatly hampered/affected;

NOW, THEREFORE, on motion of Hon. Rexfel Trivilegio, Chairman, Committee on Rules, Ordinances, resolutions and Legal Matters and duly seconded by Hon. Remedios Torrato, Hon. Ramonita Alcala and Hon. Jonathan Torrato,

RESOLVED AS IT IS HEREBY RESOLVE, to request financial assistance in the amount of One Million Five Hundred Thousand Pesos (P1,500,000.) from the Senator Blas Ople for the construction of Baguingin-Sitio-Lino Flores to Napnapan Road, Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to furnish copies of this resolution to Hon. Senator Blas Ople, Senate of the Philippines, GSIS Building, Finance Center, Roxas Boulevard, Pasay City, Philippines for his information and appropriate action and to Hon. Mayor Myrna M. Torres for her information and guidance.
