WHEREAS, pursuant to Section 447 (a) (2) (x) and Section 458 (a) (2) (x) of RA 7160 and Executive Order No. 71 dated March 23, 1993, the powers and functions of HLURB in processing and approval of subdivision plas are devolved to local government units thru the Sangguniang Bayan in case of municipalities;

WHEREAS, to prevent needless delay and to ensure a smooth, effective, orderly and speedy processing and approval of subdivision plans as well as the performance of other HLURB's devolved functions as enumerated under Section 1 of Executive Order No. 71, this Body deems it proper and necessary to designate and give full blanket authority to capable and competent municipal officials/employees in the persons of Honorable Councilor Richard Tenerife, Chairman, Committee on Housing, Land Utilization, Zonification, Assessment and Expropriation and Mr. Jimmy Tupas, Municipal Evaluating Officer,

NOW, THEREFORE, on motion of Hon. Cornelia T. Teruel, Vice Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. George Tribunal,

RESOLVED, AS IT S HEREBRY RESOLVE, to designate Hon. Councilor Richard Tenerife and Mr. Jimmy Tupas as Approving And Evaluating Officers respectively, with full blanket authority in evaluating and approving

Municipal Subdivision Plans to sign in behalf of the Sangguniang Bayan this municipality all papers/documents relative thereto,
