Resolution No. 2000-026

RESOLUTION REQUESTING THE PENRO, PROVINCE OF ILOILO, TO ISSUE PERMIT AND THE DENR REGION VI TO ISSUE ECC TO THE FOLLOWING APPLICANTS: ERNESTO TUVIDA, (NAPNAPAN NORTE), OLIVER SILVELA JALBUNA, ARIEL TAMON (CORDOVA SUR) FELOMINO TAYONGTONG AND FELICITAS TRENTADO (BAROSONG) AND JULIET CASTOR (CORDOVA NORTE) TO EXTRACT SAND AND GRAVEL AT THE SIBAKLON RIVER WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY

WHEREAS, the PENRO, Province of Iloilo has conducted a survey on the status and condition of the Sibalom River in the Municipality of Tigbauan;

WHEREAS, the large amount of sand deposits were found to obstruct the river resulting to the rerouting of the water;

WHEREAS, a temporary rehabilitation plan to allow the extraction of sand gravel was recommended to help remove the sand deposits that obstruct the waterway,

WHEREAS, the allowance of the extraction shall enhance the source of living of the residents and will increase the income of the said barangays;

NOW, THEREFORE, on motion of Hon. Richard Tenerife, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Rene Ledesma,

RESOLVED, to request the PENRO, Province of Iloilo to issue permit and the DENR Region VI to issue ECC to the following applicants: Ernesto Tuvida, (Napnapan Norte), Oliver Silvela Jalbuna, Ariel Tamon (Cordova Sur) Felomino Tayongtong And Felicitas Trentado (Barosong) And Juliet Castor (Cordova Norte) to extract sand And gravel at the sibalom river within the territorial jurisdiction of the municipality,

RESOLVED FURTHER, to forward copies of this Resolution to the Governor, province of Iloilo, to the Office of the DENR and PENRO, to Hon. Mayor Myrna M. Torres and all concerned for their information and guidance.
