Resolution No. 2000-027

RESOLUTION REQUESTING THE PENRO, PROVINCE OF ILOILO, TO ISSUE PERMIT AND THE DENR, REGION VI, TO ISSUE ECC TO MRS. SALOME C. TAMONAN AND MRS. LUZ T. TEVES TO EXTRACT SAND AND GRAVEL AT THE SIBALOM RIVER WITHIN THE TERRITORY OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Art 100 of R.A. 7160, empowers the Sangguniang Bayan to pass a resolution for an efficient protection of the environment;

WHEREAS, an immediate rehabilitation of the Sibalom River at Barangay Bagumbayan and Napnapan Norte shall be undertaken;

WHEREAS, the Barangay officials passed a resolution endorsing the applicants to quarry at their respective allowed quarry areas to avoid further river bank destruction;

WHEREAS, the proper extraction of sand and gravel at Sibalom River will answer to the present riverbank destruction and it will also be the source of an additional income to the community;

NOW, THEREFORE, on motion of Hon. Richard Tenerife, Chairman, Committee on Environmental protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Cornelio T. Teruel,

RESOLVED, to request the PENRO, Province of Iloilo to issue permit and the DENR region VI, to issue ECC to Mrs. Salome C. Tamunan and Mrs. Luz Teves to extract sand and gravel at the Sibalom River within the territorial jurisdiction of the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward copies of this Resolution to the Governor, province of Iloilo, to the PENRO and the DENR, Province of Iloilo, to Hon. Mayor Myrna M. Torres and to all concerned for their information and guidance.
